C O R R I G E N D U M

In compliance to the Order dated 18/10/2019 passed by the Hon'ble High Court of Bombay at Goa in W.P. No.880 of 2019 filed by Shri Malcom Rodrigues and others, the Tourism Shack Policy 2019-22 has been accordingly modified as under:

1) Clause No. **2** of the said Policy may be read as *“If the number of eligible applicants is more than the number of beach shacks permitted on any particular beach, the selection shall be decided by draw of lots, and the beach shacks shall be allotted as provided below:-*

- i) *90% of the total beach shacks located on Government/public beach areas shall be allotted to those applicants having **minimum of 03 years** of experience or more; in the respective District.*
- ii) *The remaining 10% of the total beach shacks shall be allotted to other applicants having experience of **less than 03 years or without experience**, in the respective District.*

2) Clause No. **18** of the said Policy may be read as *“fee structure to be deposited by the successful applicants who are in categories of having experience of **3 years and above** as proposed in the Policy 2019-2022 is as below”:*

At stretches: 'A'= Rs.1,00,000/- 1styear (i.e. 2019-20)
Rs.1,10,000/- 2nd year (i.e. 2020-21)
Rs.1,25,000/- 3rd year (i.e. 2021-22)

* **At stretches: 'B'** = Rs.75,000/-1st year (i.e. 2019-20)
Rs.85,000/- 2ndyear (i.e. 2020-21)
Rs.1,00,000/- 3rd year (i.e. 2021-22)

3) Clause No. **19** of the said Policy may be read as *“fee structure to be deposited by the successful applicants who are in the category of having experience of **less than 3 years or without experience** as proposed in the policy 2019-22 is as below”:*

- a) Rs. 50,000/- 1st year (i.e. 2019-20)
- b) Rs. 60,000/- 2nd year (i.e. 2020-21)
- c) Rs. 70,000/- 3rd year (i.e. 2021-22)

In compliance of the Order of the Hon'ble High Court, applications are also invited from the eligible shack applicants as per amended Tourism Shack Policy 2019-22. The last date of submission of such applications is **28/10/2019 upto 5.00 pm.**

Applicants with experience of **03 years and above** who have already applied earlier in response to Notice No. 7/7(511)/2019/ DT/2254 dated 04/10/2019 (Shack Policy 2019-22) need not apply afresh as they will be re-categorized accordingly in terms of the Hon. High Court Order. Further, they may either amend/modify their application if desire on or before **28/10/2019 upto 5.00 p.m.**

Further, the draw of lots for selection of applicants and selection of places/locations will be held on **30/10/2019** from **11.00 am** onwards in the below mentioned offices:

1. RFC, Paryatan Bhavan, Patto, Panaji – Goa, for North Goa District.
2. RFC, Mathany Saldanha Complex, Margao – Goa for South Goa District.

Rest of the contents remains the same.

N.B:

- 1) In compliance of the Hon. High Court directions, permissions issued by this Department prior to 1998 shall not be considered for the purpose of experience.
- 2) Applicants who have already applied and desires for addition/deletion of permission/NOC's or any other documents may contact the RFC of the concerned District.
