DETAILED TENDER NOTICE (E-TENDERING MODE ONLY)

Sub: Development, Operations and Maintenance of Mini Convention Center at Margao, Salcete Goa.

Department of Tourism, Government of Goa invites e-tenders from single entities, joint ventures, and consortia for "Development, Operations and Maintenance of Mini Convention Center at Margao, Salcete Goa." with the following minimum eligibility criteria:

- Independent private legal entity incorporated / registered in India: proprietorship concern, partnership firm, Limited Liability Partnership (LLP), private limited company registered under Companies Act 1956 or 2013, public limited company registered under Companies Act 1956 or 2013 including government-owned entities. Foreign entities are allowed.
- A group of entities (the "Consortium"), a combination of the abovementioned legal entities, with a formal intent to enter into a Consortium agreement. Consortium of maximum 3 (three) members is allowed.
- The entity should have cumulative experience in construction / development of real estate* with minimum built-up area of 3,500 sqm and minimum value of INR 15 crore (excluding land cost) anywhere in the world in the last 10 years before the bid due date.

AND

 The entity should have cumulative experience of operations and maintenance of real estate* with minimum built-up area of 3,500 sqm and minimum value of INR 15 crore (excluding land cost) anywhere in the world for a period of 5 years before the bid due date.

* Real Estate projects include minimum 4-star hotels / resorts, convention centres, exhibition centres, commercial complex, community centres, commercial offices, clubs, banquets, retail high street / malls.

- Average annual turnover of any 3 (three) of the 5 (five) financial years i.e., 2017-18, 2018-19, 2019-20, 2020-21 and 2021-22 should be at least INR 15,00,00,000/- (INR Fifteen crore only).
- The Single entity should have positive net worth as on 31 March 2022. In case of Consortium, the Consortium should have combined positive net worth as on 31 March 2022.
- The Single Entity / any member of the Consortium:
 - a. Should not be involved in any major litigation such as fraud and FEMA violations.
 - b. Should not be involved in any conflict of interest situation.
 - c. Should not have been blacklisted by any Central Government / State Government / PSU in India.
 - d. Should not have any active disputes with Department of Tourism (Government of Goa) or Goa Tourism Development Corporation Limited (GTDC).
 - e. Should not have been disqualified in any tenders of Dept. of Tourism, Govt of Goa or Goa Tourism Development Corporation Limited (GTDC) in the past due to material misrepresentation or fraudulent submission of any documents.
- All experience certificates must be certified by Chartered Accountant.

- 1. Attested copy of valid Incorporation Certificate of the company / firm. In case of a partnership firm, attested copy of Partnership deed.
- 2. Attested copy of GST certificate.
- 3. Attested copy of PAN Card. In case of a Bidder registered outside India, the copy of PAN Card will not be required.
- 4. Mode of Payment towards Cost of the Tender Document, Bid Security & Tender Processing Fee: To be paid online through e-payment mode via NEFT / RTGS / Net Banking with pre-printed challans available on e-tendering website and directly credit the amount to ITG account as generated by challans for NEFT / RTGS.
