**DETAILED TENDER NOTICE**  
**(E-TENDERING MODE ONLY)**

**Appointment of a Project Management Unit (PMU) for providing Project Management Support on various Tourism works undertaken by Goa Tourism Board (GTB), Government of Goa**

The Department of Tourism, Government of Goa invites e-tenders from independent private legal entity, Partnership Firm, Limited Liability Partnership (LLP), Public Limited Company or a Private Limited Company for “**Appointment of a Project Management Unit (PMU) for providing Project Management Support on various Tourism works undertaken by Goa Tourism Board (GTB), Government of Goa**” with the following minimum eligibility criteria:

- Independent private legal entity, Partnership Firm, Limited Liability Partnership (LLP), Private Limited Company, Public Limited Company.
- The agency should have been operational for at least **8** years.
- No consortium will be allowed.
- The agency should have experience in providing Project Management Consultancy for tourism related projects for various State Tourism Departments/Boards/PSU's across India in last **5** years.
- The agency should have executed atleast one large scale tourism project at Central Ministry.
- The agency should have minimum 100 regular employees on their payrolls or contract at the time of Agreement signing.
- The Agency:
  - a. Should not be involved in any major litigation such as fraud and FEMA violations.
  - b. Should not be involved in any conflict-of-interest situation.
  - c. Should not have been blacklisted by any Central Government / State Government / PSU in India.

- d. Should not have any active disputes with Department of Tourism, Government of Goa or Goa Tourism Development Corporation Limited (GTDC).
- e. Should not have been disqualified in any tenders of Dept. of Tourism, Govt. of Goa or Goa Tourism Development Corporation Limited (GTDC) in the past due to material misrepresentation or fraudulent submission of any documents.
- All experience certificates must be certified by Chartered Accountant.

Mode of Payment towards Cost of the Tender Document, Bid Security & Tender Processing Fee: To be paid online through e-payment mode via NEFT / RTGS / Net Banking with pre-printed challans available on e-tendering website and directly credit the amount to ITG account as generated by challans for NEFT / RTGS.
