1. PROJECT BACKGROUND

2.1.1. Apart from the tourism activities mentioned under clause 2.1 above, the Applicants may provide proposal for any other Tourism Activities that are unique, transformative, sustainable and creative. However, the Authority reserves the right to consider such tourism activity for purpose of evaluation.

3. MINIMUM ELIGIBILITY EXPERIENCE

4.1 Any applicant fulfilling the below mentioned minimum eligibility experience are invited to apply to the Authority as per formats provided in Annexure.

Minimum Eligibility

- Independent private legal entity incorporated / registered in India -proprietorship, partnership firm, Limited Liability Partnership (LLP), private limited company registered under Companies Act 2013, public limited company registered under Companies Act 2013 including Joint Ventures, government-owned entities.
- Average annual turnover in any 3 (three) financial years of the last 5 (five) financial years namely, 2018-19, 2019-2020, 2020-21 and 2021-22, 2022-23 should be at least INR 50,00,000/- (Rupees Fifty Lakh only).
- Net Worth of at least INR 25 Lakh as on 31 March 2023.
- The applicant should have a clean record without any involvement in major litigation, such as fraud and FEMA violations. They should also have no conflicts of interest and should not be blacklisted by any Central Government, State Government, or PSU in India. Additionally, they should not have any ongoing disputes with the Department of Tourism (Government of Goa) or Goa Tourism Development Corporation Limited and should not have been disqualified from past tenders due to material misrepresentation or fraudulent submission of documents.

4. SCREENING OF APPLICATIONS

- 5.1. The Authority, through an Empowered Committee shall screen the applications and project reports received through the Expression of Interest (EOI).
- 5.2. Upon evaluation of the aforesaid EOI application along with the plans and supporting documents, the Authority will invite the Shortlisted Private Entities for a technical presentation before the Empowered Committee of the Authority. During the technical presentation, the shortlisted Private Entities are required to showcase:
 - Brief introduction about the proposed Tourism Activity
 - Proposed timeline for introduction of the Tourism Activity in the state

- Relevance of proposed Tourism Activity in Goa's context
- Breakeven analysis for the proposed Activity and the proposed plan for marketing the activity to customers
- Estimated revenue generation to the State
- Estimated employment potential to the State
- Type of workforce required by the Activity, proposed plan for sourcing them and training offered to them
- Perceived risks in the Project and proposed risk mitigation plan
- 5.3. Based on evaluation of the merit of the Tourism Activity, the Authority will release a final list of "Private Operators", which are invited for introduction and operations of tourism activity(s) in the State.

5. SUPPORT PROVIDED BY THE AUTHORITY

- a. The Authority shall extend the following support to the Private Operator to facilitate them in introduction of tourism activity(s) in the State as approved by the Empowered Committee:
 - Registration of activities of the Private Operator under the appropriate category of tourism trade by collecting the required registration fees.
 - 2) Suitable assistance to the Private Operator in securing necessary No Objection Certificate (NOCs), permissions, and approvals from various statutory authorities, on best efforts basis. For avoidance of the doubt, while the Authority provides necessary assistance to the Private Operators, the ultimate responsibility for securing these permissions lies with the Private Operator only and the Authority cannot be held responsible for the same.
 - 3) Evaluating any land or infrastructure requirements for introduction of the Tourism Activity(s) in the State, and necessary assistance in arranging the same on independent commercial basis with the respective owners on best efforts basis.
 - 4) Provide reasonable assistance in marketing / promoting the Tourism Activity(s) by showcasing them through their social media handles, printed materials at various travel marts and exhibitions, as attended by Department of Tourism, Govt. of Goa or GTDC.
 - The Private Operator shall be granted permission to prominently display the Goa Tourism brand in their office and promotional content.
- b. The Authority shall extend the aforesaid support on non-exclusive basis, allowing for fair competition and equal opportunities among multiple operators operating in the same category of tourism activities.

6. RIGHT TO CANCEL THE EOI PROCESS

6.1. The Authority may cancel this EOlprocess at any stage without assigning any reasons whatsoever and will not be liable to compensate any Applicant on any grounds whatsoever. The Applicants shall not be entitled to refund of cost of documents or other costs in case the EOI is cancelled for whatsoever reason or without assigning any reason.
