- Participation confirmation will be on first come first serve basis and as per availability of space at Goa tourism pavilion. Goa Tourism strictly reserves the right for final confirmation and allotment of space for the co-exhibitors.
- I / We hereby solemnly undertake / declaration that the particulars stated above is true and correct to best of my / our knowledge and belief. Any information, if found to be incorrect, wrong or misleading, we render the company liable to rejection.
- Only the Co-Exhibitor name mentioned above will be allowed to attend allotted table.
- There will be 50% space for 5 star hoteliers & 50% for the tour operators. The allotment and confirmation will be done on first come first serve basis or on mutual understanding. The space will be available for interchange if the space reserved for one category is not utilized.
- Those members, who are registered with the Department of Tourism under the Registration of Tourist Trade Act, will be eligible / permitted to participate on Goa stall.
- For National exhibitions/Fair the organization/participants shall pay Rs. 10,000/- per person as participation fees.
- Maximum one member per organization will be allowed to participate, however in case of second member, additional amount of Rs. 15,000/- will be charged for national events.
- Participation fees will be Non-refundable.
- The participants will have to obtain badges directly from the organisers at their own cost.
- All instructions issued by Goa Tourism to participants/officials, will have to be meticulously followed.
- All participants will have to take care of their belongings at their own risk.
- Each organisation/participant will be provided with one table and one chair, and anything above, will be charged as per actuals, depending on the rates charged by the organizer subject to availability.
- Co-exhibitors will not be allowed to display/erect any standee, posters etc in the Goa Pavilion and are directed not to leave counter unattended.
- Co-exhibitors shall be permitted to promote only Goa-based tourism establishments/services.
