Vedanta Ltd. is fixed on 24-01-2021 at Government Village Play Ground, Navelim, Near Vividha Higher Secondary School, Navelim, Sankhali-Goa.

And whereas, the undersigned being the District Magistrate, prescribes the following procedure for the conduct of the process of public hearing:-

- a) The GSPCB shall restrict the number of persons gathered to 100 persons at the venue for single hearing and conduct the Public Hearing with adequate social distancing and other safe guards in view of COVID-19 as issued by the Government from time to time.
- b) Use of virtual platform/online facilities shall also be employed in addition to the physical Public Hearing Process.
- c) The GSPCB may also obtain responses in writing from concerned persons having a plausible stake in the environmental aspects of the project or activity, through electronic, or paper means.
- d) The hearing for proposed Public Hearing in North Goa shall commence from 10.30 a.m. till 7.00 p.m. on 24-01-2021. If the number of participants is more than ceiling, more than one Public Hearing shall be conducted by staggering the time and/or dates.
- e) In case the speakers are less, the hearing will conclude as soon as the last speaker has spoken and will not continue thereafter.
- f) To register as participant/speaker, he/she shall send following details to GSPCB at goapcb@gspc.in:

- g) Participants/speakers, who wish to join virtual hearings, must sign an undertaking (as per the format enclosed as Annexure A) and send

the same along with above details (scanned copy).

- h) Valid ID Proof shall be one of the identification documents as prescribed by the Election Commission of India and participation will be allowed only for those having valid ID proof. No persons shall be allowed inside the venue or allowed to attend Virtual Hearing without valid ID proof as prescribed.
- i) The details at Sr. No. (f) shall reach GSPCB by 5.00 p.m. on 20-01-2021.
- j) The participants will be communicated through SMS on the registered mobile number latest by 22-01-2020 about the date allotted to them for physical participation.
- k) The speakers will be communicated through SMS on the registered mobile number latest by 22-01-2020 about the date and time slot allotted to them to speak and express their views.
- Those who have registered as participants/ /speakers for attending through Virtual Mode would be sent meeting details on their registered email ids.
- m) Standard Operating Procedure (SOP) and General Instructions for Virtual Hearing are annexed as Annexure B.
- n) Only registered participants/speakers would be allowed to enter the venue or attend Virtual Hearing.
- o) The speakers who wish to express their views shall be given a maximum time slot of 10 (Ten) minutes only. The same will be communicated to speakers on their registered mobile number through SMS.
- p) The NGOs who wish to express their views shall do so through only one authorized representative per NGO who shall also compulsorily register as per Sr. No. (f). The NGO representative shall send an authority letter in original from the competent official of the NGO to GSPCB through electronic or paper mode.
- q) The speakers shall be allowed to speak in the allotted time slot only. In case the speaker is not available at the particular slot when his/ /her name is announced then he/she will not be allowed to express his/her view thereafter when his time slot is missed.
- r) No separate audio/video presentation of any kind will be allowed on the part of public participants/speakers. Such presentation if

any, shall be submitted in the form of soft copy before the end of the public hearing and at the designated desk at the venue which will be considered.

- s) Those participants who are unable to attend the public hearing and/or those who could not get the slot to express their views, will be allowed to submit all their concern in writing and submit at the desk set up.
- t) Participants can also submit their concern in writing to the GSPCB before 24-01-2021.
- u) The participants shall strictly restrict their suggestion/objections to the matter in question and shall retrain from making long speeches. Further, the suggestions/objections already raised by the previous speaker shall be avoided.
- v) The speeches of participants shall also be strictly restricted only to the matter in question and shall not contain any political or personal criticism of any nature which will not be permitted.

Now therefore and in view of above all the participants are hereby required to strictly adhere to the above prescribed procedure for conduct of Public Hearing without any deviations.

Format of Undertaking

ANNEXURE B

Standard Operating Procedure (SOP) for Virtual Hearing

Participants shall follow the following protocol for hearings through virtual mode.

- 1. For conducting hearings through Virtual Mode (VM), details would be sent through email in advance to all participants/speakers who opted to join the hearing through Virtual Mode.
- 2. The participants/speakers, who wish to join virtual hearings, must sign an undertaking as given in Annexure-A and send a scanned signed copy thereof through e-mail to GSPCB.
- 3. The participants/speakers are expected to conduct in a decorous manner at all times during virtual hearings.
- 4. The participants/speakers shall not share/ /disclose/disseminate the link shared with them for the purposes of VM with any other person.

General Instructions

- 5. For enhanced Virtual Meeting quality, use of headphones is recommended.
- 6. The standard protocol about one person speaking at a time in Virtual Meeting shall be strictly followed.
- 7. The speakers shall be given opportunities to present their case. Any attempt to jump in during the presentation by another speaker may disrupt the proceedings. Such conduct may also invite 'muting' of the microphone of the disrupting speaker.
- Cross talking or discussion could be done only after the microphone has been put in 'mute' mode.
- 9. The participants/speakers must ensure that no other device or application is connected

to or using the bandwidth when the hearing is in progress.

- The participants/speakers while joining the VM, shall enter their name in the following format: First name-Second name- Participant/ /Speaker.
- 11. Upon having joined the hearing in virtual mode, the speaker shall introduce himself/ /herself to the Chairperson and thereafter, shall wait for the instructions from the Chairperson. On being asked, the speaker may make submissions and on completion of the submissions, shall at once 'mute' the microphone of the respective device. If the Chairperson requires the speaker to make further submission(s), the Speaker may then 'unmute' the microphone of the device and again, on completion of the submission, put the microphone on 'mute' mode.
- 12. Simultaneous submissions by more than one speaker at any given time shall be allowed.
- Parties are required to stay online (but in Self Mute mode) till the Chairman concludes the hearing of their matter, whereafter the parties may disconnect from video-conference.

Whereas, as per Ministry of Environment and Forest, Coastal Regulation Zone Notification 2011, clause 8(vii) the beaches such as Mandrem and Morjim has been designated as turtle nesting sites and protected under the Wildlife Protection Act, 1972 and these areas shall be surveyed and management plan prepared for protection of these turtle nesting sites.

And whereas, as per 234th meeting of the Goa Coastal Zone Management Authority at Case 1.8,

the Authority has decided to declare entire beach stretch of Mandrem and Morjim covering the CRZ area of 0 to 500 meters as "Silence Zone". The noise levels in this area shall be as per the prescribed CPCB guidelines.

And whereas, Rule 3 (ii) of the Noise Pollution (Regulation and Control) Rules, 2000, the State Government shall categorize the areas into Industrial, Commercial, Residential or Silence areas/zones for the purpose of implementation of noise standards for different areas. Now therefore, in exercise of the powers vested in me as per the Rule 2(c), of the Noise Pollution (Regulation and Control) Rules, 2000 I, R. Now therefore, in exercise of the powers conferred on me under Sections 115 & 116 of the Motor Vehicles Act, 1988, and as recommended by the Dy. - 3. No construction material should be dumped on the road causing obstruction to the road users and motorists.
- 4. Sufficient traffic signages/directional boards shall be erected at all the diversion points for the information of motorists and other road users.
- 5. The PWD undertaking the work of retaining wall, before blocking the approach road to any house or colony, should construct temporary pathway to allow to and fro movements of the vehicles of the residents.
- 6. Notice should be given to Press/Media regarding diversion of the road on receipt of this Order.
- 7. Prior permission from other competent authorities should be obtained in advance.
- 8. NOC from Mapusa Police Station should be obtained.

- 9. Material used for barricading the road should be painted/pasted with fluorescent paint/tape for illuminating the same during the night time.
- 10. After completion of the work enter place should be cleaned from all types of debris, mud etc. and the road should be brought down to its normalcy for the use of motorists and other road users.
- 11. Material used for barricading of road should be removed immediately and the road should be thrown open for vehicular flow after resurfacing the same.
- 12. The work should be completed on or before 15-01-2021.
- 13. This permission is subject to cancellation/ /revocation at any moment.
