General Instructions

- Official website of NIDHI is <https://nidhi.qcin.org>
- For NIDHI Registration, applicant may keep ready the following:
 - ✓ Valid Email ID
 - ✓ Valid Mobile Number
 - ✓ PAN Number of Unit/Owner, as applicable
 - ✓ GST Number of Unit/Owner, as applicable
 - ✓ FSSAI License Number, as applicable
- An **OTP** will be sent on the **Unit Email ID and Mobile Number** provided for verification
- After email verification and mobile number verification, NIDHI pledge will be administered to the unit before submitting the application, then the case will be forwarded to respective **State/UT (State/UT Nodal Officer)** for verification.
- State/UT Nodal Officer will **verify or reject** the application with justification remarks
- After verification, a NIDHI ID (**NID**) with login/password and Pledge Certificate (Safe and Honorable Tourism) will be sent on the **verified Email ID**. Applicants can then avail NIDHI services from their dashboard by logging in.
- Applicants can also view profile, download the pledge certificate, apply for services and download documents from their dashboard.
- If application is rejected, then applicant may re-apply again with correct details.






