(Village) do solemnly affirm and state as under:-

- (1) That we operate a Restaurant / Hotel / Guest House/ Private Shack (as applicable option may be retain) by name and Style in the Survey no. at Beach stretch, in, Village, Taluka.
- (2) That our (Restaurant / Hotel / Guest House/ Private Shack (as applicable option may be retain) is registered with (Village Panchayat / Tourism Department) and have obtained NOC from them to operate my Restaurant / Hotel / Guest House/ Private Shack (as applicable option may be retain). A copy of the NOC issued by the Village Panchayat / License issued by the Tourism Department as applicable) is attached herewith for ready reference as Annexure – I.
- (3) That I / we have not encroached into the government land (beach area) and that my Restaurant / Hotel / Guest House/ Private Shack (as applicable option may be retained) is constructed / built in my own property or property taken by me / us on lease.
- (4) That I have submitted application to the Department of Tourism, Panaji, for issue of permission for placement of deck beds and umbrellas, Chairs and Tables in front of my (Restaurant / Hotel / Guest House/ Private Shack (as applicable option may be retain) at Beach stretch, Village from

October, 2022 to 31st May,2023.

- (5) That I shall abide by the “Terms and Conditions” governing the grant of N.O.C. for placement of deck beds and umbrellas, Chairs and Tables under the policy of the Department of Tourism “ EXTENSION OF THE TOURISM SHACK POLICY 2019-22 FOR ERECTION OF TEMPORARY SEASONAL STRUCTURES, BEACH SHACKS/DECK-BEDS/UMBRELLAS/HUTS AND OTHER STRUCTURES FOR FURTHER TOURIST SEASON 2022 – 2023” and other terms and conditions as issued from time to time and that I shall only place deck beds, umbrellas, tables and chairs in front of my(Restaurant / Hotel / Guest House/ Private Shack (as applicable option may be retain) within 10 metres from plot boundary of (Restaurant / Hotel / Guest House/ Private Shack (as applicable option may be retain) and as per the area identified and demarcated by the Department of Tourism.
- (6) That in the event I am issued permission for placement of deck beds and umbrellas, Chairs and Tables from October, 2022 to 31st May,2023, I undertake to abide by the local laws in force.
- (7) That in the event of any complain received against me with documental proof, the permission so granted for placement of deck beds and umbrellas, Chairs and Tables shall be surrendered by me.
- (8) That in the event of grant of permission for placement of deck beds and umbrellas, Chairs and Tables I undertake that no foreigner shall be permitted to work and that in case of violation of the Terms and conditions, the permission issued shall be cancelled forthwith.
- (9) That I have not been convicted of any criminal offence as of date of application.
- (10) That I am aware that in case of violation of the “Terms and Conditions” governing the grant of N.O.C. for placement of deck beds and umbrellas, Chairs and Tables under the policy of the Department of Tourism under “ EXTENSION OF THE TOURISM SHACK POLICY 2019-22 FOR ERECTION OF TEMPORARY SEASONAL STRUCTURES, BEACH SHACKS/DECK-BEDS/UMBRELLAS/HUTS AND OTHER STRUCTURES FOR FURTHER TOURIST SEASON 2022 – 2023” as issued from time to time and permission issued thereunder shall be cancelled forthwith,

Security Deposit shall be forfeited to Government Treasury, deckbeds / Umbrellas / Chairs / Tables shall be confiscated at my risk and cost and I shall be debarred for applying for permission for a minimum period of three years / tourists seasons.

- (11) That I agree to assist the Lifeguards on duty for safety of lives as and when required.
- (12) That I agree to assist Department of Tourism, Tourist Security Force and the Police in reporting suspicious activities along the beaches such as paedophilia, drug peddlers of banned substances and suspicious terrorist.
- (13) That I agree to prevent activities such as of the vagabonds, beggars, masseurs, touts hawkers etc. from and around the shack/huts/tents.
- (14) That I am fully aware of my responsibilities towards keeping the environment clean and hygienic and free from all kinds of pollution.
- (15) That I am aware of the Anti-Smoking and Spitting law in force in Goa.
- (16) That I shall procure health cards for all my employees working in my(Restaurant / Hotel / Guest House/ Private Shack (as applicable option may be retain) and detailed information including photos, etc. of the employees shall be maintained and also informed to the nearest Police Station.
- (17) That I am aware that in case any information submitted by me as above is found to be incorrect, the permission granted to me shall be cancelled and the registration fee paid and the security deposit shall be forfeited to the Government and I shall be debarred from applying for permission for the next three years / tourist season.
- (18) That I shall follow all the relevant clauses of the “EXTENSION OF THE TOURISM SHACK POLICY 2019-22 FOR ERECTION OF TEMPORARY SEASONAL STRUCTURES, BEACH SHACKS/DECK-BEDS/UMBRELLAS/HUTS AND OTHER STRUCTURES FOR FURTHER TOURIST SEASON 2022 – 2023” and as applicable for placement of deckbeds / umbrellas/ chairs / tables.
- (19) That there should not be any activity, which is likely to damage or disturb flora and fauna of the nesting sites.
- (20) That depositing of debris, garbage, dust, chemicals etc. is strictly
