NOTICE INVITING APPLICATIONS FOR ISSUE OF PERMISSION FOR PLACEMENT OF DECK BEDS AND UMBRELLAS ON BEACH STRETCHES OF GOA STRETCHES FOR THE TOURIST SEASON 2022-23.

Applications for placement of deck beds and umbrellas on beach stretches of Goa as per extended Tourism Policy 2022 – 23 for the Tourist Seasons 2022 – 23 are hereby invited from the owners of restaurants / hotels / guest houses situated adjoining private properties with beach frontage to place a maximum of 20 deck beds with umbrellas or a maximum of 20 tables and 80 chairs or 10 deck beds with umbrellas and 10 tables and 40 chairs. The application forms along with the extended Tourism Policy 2022 – 23 governing the terms and conditions for placement of deck beds and umbrellas on beaches stretches of Goa for the tourist season 2022-23 is uploaded on the official website of Tourism Department: www.goatourism.gov.in, for information of the prospective applicants/general public.

Applicants may note that permission for placements deck beds and umbrellas shall be permitted within 10 metres from plot boundary of applicant towards seaward side and after conducting inspection of site conditions, available area, frontage available adjacent to private plot etc.

The deck-beds allotted to the hotels shall be placed strictly within 10meters or within area to be demarcated by officials of the Tourism Department from the outer boundary of the hotel property, whichever is less, without causing any congestion on the beach and without affecting the movement of tourist and the lifeguard/tourist police operations. The number of deck-beds and umbrellas so allotted may be increased if the additional deck beds does not cause any inconvenience to General public by specific order to be issued by the Department by charging requisite fees as stipulated in the Tourism Policy for the Tourist Season 2022-23.

The Application Fee shall be **Rs. 10,000/-** (non-refundable). The applicant shall required to submit only one application form for the Tourist Season 2022-23 along with the Security Deposit of **Rs. 50,000/-** and fees of **Rs. 1,00,000/-** per season in category **A Beach** stretches plus applicable taxes and **Rs.75,000/-** per season for Category **B beach** stretches plus applicable taxes. The demand drafts have to be drawn on any Nationalized Bank in favor of Director of Tourism, Panaji - Goa, payable at Panaji – Goa.

Applicants will also have to pay **Rs.10,000/-** for ‘A’ and ‘B’ Beach stretches and as Registration Service Charges plus Service Tax as applicable and DD shall be drawn in favour of GOA ELECTRONICS.

Interested applicants shall submit the applications duly filled forms with necessary fees prescribed (Demand Drafts) and following documents to the Registration Facilitation Centre (RFC), Paryatan Bhavan, Patto, Panaji – Goa and Registration Facilitation Centre (RFC), South Zone Office, Mathany Saldanha Complex, Margao - Goa during working days on or before **02/12 /2022 upto 5.00 p.m.**

1. Affidavit
2. PAN Card
3. GST Registration Certificate
4. Copy of permissions / licenses issued by the local body
5. For hoteliers, a copy of the registration certificate issued by the Department of Tourism.

The Department of Tourism reserves the right to consider or reject any application received depending upon the site conditions/availability of space. Applications received without demand drafts and documents as stipulated above shall be summarily rejected.
